Following a <u>Statutory Public Meeting on January 22, 2024</u> and extensive public input, a recommendation report for the <u>Bowmanville East Urban Centre Secondary Plan</u> will be presented at the upcoming <u>Planning and Development Committee meeting</u> on September 16, 2024 at 5:00 p.m.

The updated Secondary Plan for this area will create a unique community identity that celebrates Bowmanville's heritage while accommodating growth and change. The Plan area includes the historic downtown, Bowmanville Hospital, Bowmanville Mall, and former Goodyear lands. The area will be transformed with a potential medical campus to support the Bowmanville Hospital and mixed-use development opportunities along King Street East, in the east business district. The former Goodyear lands is planned to feature mixed-use development and is envisioned to include park space and a new connection to Bowmanville Creek.


