




MAP A2 LAND USE - COURTICE URBAN AREA OFFICIAL PLAN of the MUNICIPALITY OF CLARINGTON





Environmental Assessment (EA)

What is an Environmental ? Assessment

An EA is a multi-phased study identifying the potential positive and negative environmental effects of municipal infrastructure projects.

EA Process





What is an Integrated Approach to the Secondary Plan and Environmental Assessment

Coordinating the planning and approval processes for a proposed development so that it satisfies the requirements of the Planning Act and the Environmental Assessment Act simultaneously

The "Integrated Approach" is outlined in the Municipal Class EA document (Municipal Engineers Association, October 2000, as amended in 2007, 2011 and 2015) which is an approved process under the Environmental Assessment Act.



Final Outcome



- Official Plan Amendment describes the objectives, intent and purpose of the Secondary Plan, and provides the legal framework for it to be used
- SE Courtice Secondary Plan land use plan and policies to implement the vision developed through this planning study
- Urban Design and Sustainability Strategy land use, building and landscape provisions that must be followed when submitting a development application
- Enacting Zoning By-Law –allowances and restrictions for each land use in the Secondary Plan
- Environmental Assessment description of the impacts on the environment of the main roads in the new community, and requirements to offset the impacts
