RE: Report Setting Out All Candidates and Indicating Compliance

Subsection 88.23(4) of the Municipal Elections Act (MEA) states that "the clerk shall make available to the public a report setting out all candidates in an election and indicating whether each candidate complied with section 88.25". Section 88.25 is the requirement to file financial statements.

Accordingly, please find below a list of all candidates in the 2022 Clarington Municipal Elections and an indication of whether they are in compliance (i.e., have filed financial statements) or are in default. Until the next regular election (in 2026) has taken place, candidates in default are ineligible to be elected, or appointed, to any office to which the MEA applies.
